I hereby undertake to:

- 1. Accommodation for pets must be booked for One Bedroom Suite, Two Bedroom Suite and Three Bedroom Suite. We are unable to accommodate pets in our Studios.
- 2. Veterinarian's Certificate must be provided that the Authorized Pet(s) is in good health, has had the necessary inoculations and booster shots, is spayed or neutered, and declawed in the appropriate cases. The Certificate must be updated annually. The Certificate must be presented prior to the Authorized Pet(s) coming onto the premises. If the animal is too young, the Authorized Pet will be neutered or spayed when the Authorized Pet(s) reaches the suitable age.
 - Dogs must have valid vaccination against canine distemper, canine hepatitis and canine parvoviral infection.
 - Cats must have valid vaccination against cat flu (feline calicivirus and feline viral rhinotracheitis) and cat enteritis (ie feline panleukopenia/ feline parvovirus).
- 3. A Veterinarian's Certificate must be submitted prior to admission of the Authorized Pet(s) certifying that the Authorized Pet(s) has received a flea treatment within ten days prior to admission. The Management reserves the right to require the treatment more frequently should problems arise.
- 4. Certificate indicating proper licensing by Agri-Food & Veterinary Authority of Singapore must be provided prior to bringing the Authorized Pet(s) onto the premises. The Certificate must be updated annually.
- 5. Agrees to comply with all Health and Safety Codes and all other applicable governmental laws and regulations relating to pets.
- 6. Maximum pets allowed: 2 pets per apartment
- 7. Size for Dog Breeds allowed: Small sized (Weight: up to 14kg, Height: up to 25cm)
- 8. Pet Fee: SG\$20.00+ per pet per day (up to 14 kg and a maximum of 2 small pets) SG\$300.00+ per pet per month (up to 14 kg and a maximum of 2 small pets) All fees stated above are subject to prevailing government taxes.
- 9. An additional amount of SG\$100.00⁺⁺ will be charged for cleaning the apartment at the end of stay.
- 10. In the event if the Authorized Pet(s) defecate within the apartment, an amount of SG\$50.00++ will be imposed for additional cleaning.
- 11. Take all necessary steps to ensure, to the satisfaction of the Management, that the Authorized Pet(s) will not be a source of annoyance, noise, nuisance and/or danger to the other occupier(s) of neighboring premises or along common property.
- 12. The Authorized Pet(s) must be kept in the apartment at all times or carried in a carrier when in the common areas or hallways of the building.

- 13. The Authorized Pet(s) is not allowed at our Grand Lobby, Gather Executive Club, Collective restaurant, Outdoor infinity pool, Move Fitness Center, the Living Room and the Bar.
- 14. The Authorized Pet(s) must be on a leash at all times and a muzzle must be put on when on the grounds of the complex. At no time will the Pet be allowed to roam free.
- 15. The Authorized Pet(s) must be on a leash and a muzzle must be put on when Housekeeping is cleaning the apartment.
- 16. Take all necessary steps to ensure, to the satisfaction of the Management, that the Authorized Pet(s) will does/do not cause any damage to the property of the occupier(s) of neighboring premises or to the common property.
- 17. Ensure that the Authorized Pet(s) will not defecate at the neighboring premises or at the common property, and be responsible for removing all such defecation; and
- 18. Be responsible and bear all liabilities for all interference with peaceful enjoyment, damage to properties and/or personal injuries caused by the actions of the Authorized Pet(s), and to indemnify and holds Dao by Dorsett AMTD Singapore Management harmless for all or any liability, damage. Loss, costs and expenses incurred by the Management as a result of the actions of the Authorized Pet(s).

I understand that the Management has the right to review the consent to allow me to keep the Authorized Pet(s) at Dao by Dorsett AMTD Singapore and that the consent is revocable at the Management's absolute sole discretion. I understand that the Management's decision to revoke is final and conclusive and that the Management is not obliged to provide any reasons for the revocation of its consent.

Upon revocation of the Management's consent, I undertake that I shall immediately remove the

Authorized Pet(s) from my apartment and/or common property.
